The Chairman, Mike Stahl, called the meeting to order at 7:30 p.m. and led the group in the pledge of allegiance.

## **PUBLIC PORTION:**

Steve Burt, President of the New Haven Rowing Club (NHRC), was present to report the regatta went well with no real issues and the thanked the LHAMP for their great support. He also discussed an encounter between a LHAMP officer and NHRC member. The officer commanded the member back to the dock due to no life jacket. There was some discussion and disagreement between the two as to the requirement for having a jacket on board. The board discussed with Mr. Burt and varying opinions on the subject mater were reviewed. Mr. Burt stated the NHRC position is they are governed by Coast Guard regulations not State Law. The LHA Chairman informed Mr. Burt that the LHAMP was to enforce CT State boating as trained by the DEEP. If NHRC took exception to this they would have to address it with DEEP. Mr. Burt thanked the board for their time and excused himself.

Patrol:

Patrick Kilby, LHAMP Chief, reported that the season ended well. He stated he is concerned that the patrol will be down 3 officers and 1 boat handler next year. He also noted that training would be available from DEEP next year however it would most likely be early, perhaps in January. He asked the board to consider hiring more officers before the end of the year so that they could attend the training in January. The board agreed that more officers would most likely need to be added. The decision to add, and how many, was tabled until the November meeting. The loaner radios were turned over to DEEP and new radios would be needed for next year. This discussion was also tabled for November.

Water Quality:

Scott Ames reported testing was complete for the season and results wee typical.

Weed Harvester:

Paul Behuniak reported that the weed harvester was still in the water and would be removed within the week. Repairs will be necessary before next season.

Vessels and Equipment:

The boats have been pulled and the docks will come out in the next couple days.

The board thanked Sergeant Williams for his time but stated they would need time to review the agreement again and to review the list of questions and concerns that were last submitted.
