Patrol:

The Chief, Brian Brainard, reported that the Lake Patrol classes were complete and the final exam will be tomorrow. He indicated he expected all to pass. Once the results are known he will place an order for uniforms. The CPR class was completed and \$200 was due to the instructor for the 8 people that attended. Officers also all took a 2hr online sexual harassment class. The radar gun needs to be sent off for calibration. The Chief is putting the finishing touches on the Marine Patrol Agreement. DEEP informed the chief that the new safety lanyard law was a federal law only and that DEEP only enforced Connecticut Law. It was their opinion that the new law did not apply to Lake Housatonic and as such instructed the Lake Patrol to not enforce it at this time.

Water Quality: No report at this time Weed Abatement:

Jim Olson reported that he was getting ready to sign the contract. The amount had been reduced due to the sale of the harvester. Still targeting mid-July for tape grass and first week of August for Milfoil. Heavy treatments would be applied at Birchbank and Wholand to try to combat Illinois Pond Weed. Permits still in process.

Vessels and Equipment: Jim Olson reported that the weed abatement contractor Solitude has purchased the weed harvester.
