Patrol:

Chief Brainard reported that the season went well and has come to a close. Some good news from DEEP is that the DEEP Seargent appointed to the LHAMP just got an officer assigned to him to help with his load. And that DEEP will be running the academy next year for training officers. The LHAMP needs three more officers. As such, and with the academy available next year, an ad will be placed soon for hiring officers for next year. The Chief is still investigating what dash and or body cameras should be purchased for the patrol. There was some discussion about possibly checking boat registrations and licenses at the park prior to launching. The Chief also noted he had someone in mind as possibly filling the assistant chief position.

Water Quality:

Scott Ames reported that the October test results were received and were typical. Testing has been completed for the season. A report will be generated after the new year.

Weed abatement:

Jim Olson reported that the end of year survey was completed. They are currently working on updating the maps. He will begin the process of securing a new permit after the new year.

Vessels and Equipment:

Mike Stahl reported that one boat needs an ignition switch. There was some talk about purchasing hand held radios for the boats. The Chief will investigate further and make recommendations at the next meeting.
